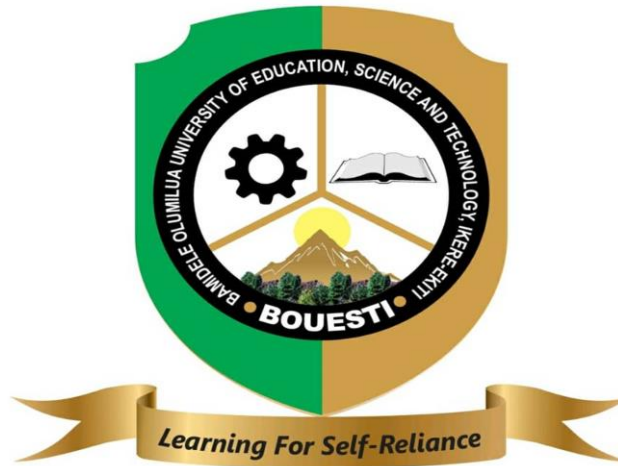

## **EDITORIAL POLICY**

### **General Policy**

The Journal Editor-in-Chief has the objective to keep international practices in research and publications by monitoring the growth of the Journal through relevant indexing institutions. It is an emerging journal of the Department of Economics, Bamidele Olumilua University of Education, Science and Technology, Ikere-Ekiti (BOUESTI) Nigeria.

This emerging Journal is multidisciplinary and accepts manuscripts from Economics, Social Sciences, Management Sciences and Education. The Editor-in-Chief accepts articles that are empirical, reviews, conceptual, book review, position papers and related styles of paper writing. It accepts development and policy papers from well-researched topics and institutions. Specifically, articles from Economics, Development Studies, Political Science, Sociology, Geography, Entrepreneurship, and Research in Economics, Social Science, Education, experimental and other related topics to Economics, Social and Education are accepted for publication.

The journal is a quarterly publication running four (4) issues per year. It runs both print and online versions. The journal publishes special issues in the field of education, economics and social sciences.

### **Guidelines for Authors and Reviewers**

#### **Title and Authors**

The title of the manuscript and authors should be in separate document to allow for blind review. The Journal Editor accepts only title with maximum of 15 words.

#### **Abstract**

The content of the abstract should not be more than 200 words which must be in block form (i.e. without paragraph) and it should be italicized). The Abstract Page must contain the Title, Abstract, Keywords and JEL classifications (as applicable to Economics and Social Sciences).

#### **Keywords**

The article should contain maximum of five (5) keywords to assist the Google and other search engines make the article accessible to readers.

#### **The Body**

For empirical studies, the body shall be divided into five sections comprising Introduction, Literature Review, Methodology, Results and Conclusion. All the five subtitles must be in capital letters. For others, follow appropriate style of organizing such manuscript. Total words of the body should not be less than 3,000 and or greater than 8000.

### **Peer and Blind Review**

The article submitted shall be subjected to a blind review. The author and reviewer should not have prior knowledge of each other. Otherwise, the article shall be retracted by the Editor. Prior to the blind review, initial review would be carried out and report would be made available to the Author.

### **Article Format**

All articles submitted to the Journal should be in Microsoft Word (MS-Word) document. It should be '12' font and single line spaced.

### **Plagiarism**

Editor-in-Chief has no tolerance for high similarity index. The accepted similarity index tolerance is 25%. Otherwise, the article shall be reverted back to the author. The index tolerance to review by the Editor-in-Chief.

### **Acknowledgments**

Author should acknowledge the sponsor of the article submitted to it (e.g. TETFund), contributions of anyone who made certain contribution to the paper and the affiliated institution if the article comes from student' thesis/project. The article should put the acknowledgements in a separate Ms-Word document when submitting the manuscript.

### **Open Access and Article Processing Charge (APC)**

The journal is an open Access in which all the articles are freely accessible to scholars in Economics, Social Sciences and education. The APC of each article is \$75 for online publication. The APC shall be for the (i) article publication (ii) website maintenance and (iii) office expenses.

### **References**

Author should ensure that all cited authors in the body should be on the reference list. Author should use APA 6<sup>th</sup> Edition. **Wikipedia** is **NOT** accepted as a reference.

### **Tables and Figures**

#### ***Tables***

All tables should follow APA format. The Table(s) should be well labeled containing Arabic numerals. The title of the table should be at the Top of the Table. All tables should be in the body of the manuscript. Table should be centralized. However, a long Table can be taken to Appendix.

#### ***Figures***

All graphs in the body of the manuscript should be in APA format. It should be properly labeled and put below the Figure. The Figure should be Fig. 1 in the order of the figures.

**NOTE:** if the figure is coloured the author shall pay additional cost of the colour separation in case of Print version..

### **Consent and Ethical Clearance**

Should a research involves human and or animal investigations; the author should submit evidence of participant's consent as well as Ethical Clearance Certificate (ECC) while submitting the manuscript to the Journal Editor. This is a strong requirement for submitting article to the Journal Editor.

### **Multiple Authors' Policy**

Contributions of each author on the manuscript should be submitted to the Editor-inChief during submission
